### **Guidance**

CRGS has a programme that provides for all year 7-13 students. The programme is reviewed annually by the Careers Lead and the Careers Co-ordinator and is shared with the CRGS staff who also contribute to the development and evaluation of the programme.

**The Nominated Governor for CEIAG** is Mrs Sherryl Turner. She is involved in the review process and acts as a critical friend in this process.

The day-to-day responsibility for dealing with the various aspects of the Careers Programme is delegated to the Careers Co-ordinator, who meets regularly with the Careers Lead to discuss, plan, review and evaluate the delivery of the careers programme.

The CRGS Careers Education and IAG Policy (Information, Advice and Guidance) is reviewed at least biannually and is approved at a Governing Body meeting. The programme itself is reviewed at least annually, but – in practice – it is also regularly updated in-year as new opportunities arise that we feel are appropriate for our students.

### **Evaluation of impact**

The school measures and assesses the impact of the careers programme on students via student voice activities, including focus groups and student surveys. Parental surveys also allow the impact of the programme to be assessed. Events such as our Careers Morning, BRAG careers fairs and Futures Days involve a range of employers and education and training providers.

Feedback is always sought to help to develop the programme and this is used to develop the programme for subsequent years. We also undertake termly review and evaluation meetings with our partners and advisers from The Careers and Enterprise Company.

Destination information for students is produced and analysed each year to help us determine the most popular institutions, courses and career options taken by our students. This is evaluated in relation to students planned destinations. Destinations information is shared with students as part of the CEIAG provision, helping them make informed decisions.
