Core Purpose of the role:

- To assist in the general welfare, personal, social and classroom care of students with special educational needs.
- Under the guidance of the teacher, will support the education, personal and social development of students in class including those with special needs and/or bilingual needs.
- To establish positive relationships with students and assist them to complete structured learning activities in class and outside the classroom, ensuring they remain on task.

Role and Responsibility:

Support for Students

- To assist in the supervision of set tasks and integrated therapy for an individual/small group of students.
- To develop positive relationships with students to assist student progress and attainment.
- To assist in the devising of student's individual targets and their monitoring and review.
- To assist with movement around the school environment outside of lesson time (e.g. break / lunchtime) and during school activities.
- To assist in the development of independent social skills.
- To support students as part of a planned inclusion programme.
- To assist in the proper use of specialist aids and equipment.
- To contribute to multi-disciplinary discussions of student's need/progress.
- To assist in the development of personal organisation skills that support students' learning
- To accompany students on visits.
- To meet the needs of students in relation to welfare, hygiene, feeding, mobility.
- To administer basic first aid where appropriately trained.
- To assist in the specific medical/care needs of students when specific training has been undertaken.
- To assist with the supervision of students out of lesson times.
- To support named students when required.

Support for the Teacher:

- To assist in the classroom and with adapting work for the student's individual needs.

- To provide information to the teacher to assist in the planning of work programmes.
- To implement structured learning activities under the clear guidance of the class teacher and to assist individual/group of students to complete tasks.
- To administer routine tests and assisting in exam invigilation if required.
- To assist in the monitoring and recording of student progress.
- To assist in preparation of learning resources and tidying away.
- To assist with the maintenance of classroom equipment ensuring it is kept in a clean and tidy condition and reporting damages.
- To assist in monitoring, displaying and the removal of work displays.
- To report students' difficulties/achievements to the teacher as necessary.
- To undertake photocopying and routine administrative duties.
- To report student absence to the nominated person.
- To report information from parents/carers as directed.
- Any other reasonable duties as defined by the Deputy Headteacher/SEND/CO/HLTA.

Other Duties:

- To attend staff meetings where appropriate.
- Provide support to the SEND/CO and HLTA
- To complete a First Aid in Schools training course and maintain the certificate whilst an employee of CRGS.

Contribution to Whole School:

- To work within and promote all school policies and procedures.
- To be aware of the responsibilities relating to the safeguarding and promoting the welfare of children and young people.
- To contribute to the provision of an effective environment for learning.
- To support the promotion of positive relationships with parents and outside agencies.
- To attend skill training and participate in personal/performance development as required
- To take care for their own and other people's health and safety.
- To work positively and inclusively so that the school provides a workplace and delivers a service that does not discriminate against people on the ground of their age, sexuality, religion or belief, race, gender or disabilities.
- To uphold and promote the values and ethos of the school.
- To be aware of the confidential nature of issues arising within a school and maintain strict confidentiality at all times.

Conditions of Service:

- Conditions of service are in accordance with the National Joint Council conditions of service relating to Local Government staff.
- This post is a temporary 12-month contract.
- The working hours for the post will be for the benefit of the school but are expected to be 31.25 hours per week, term time only, Monday to Friday 9:00am to 3.45pm with a 30-minute break for lunch.
- The post holder is an employee of Clitheroe Royal Grammar School and will be expected to work at either site.
- Hours for the post will be for the benefit of the school, and therefore flexibility is essential.
